**ORDER GRANTING PRELIMINARY APPROVAL OF PROPOSAL
TO FUND WIND UP PLAN**

CONSIDERING the petition (the "**Commissioner's Petition**") filed in this matter by the Honorable J. Robert Wooley, Acting Commissioner of Insurance for the State of Louisiana (the "**Commissioner**"), which seeks to wind up the affairs (the "**Wind Up Plan**") of GULF SOUTH HEALTH PLANS, INC. ("**Gulf South**") in accordance with the Wind Up Plan attached as Exhibit G thereto, and the requests made therein; and

CONSIDERING the Petition of Intervention and for Approval of Proposal to Fund Wind Up Plan (the "**General Health's Petition**") filed by General Health System ("**GENERAL HEALTH**") and the requests made therein; and

CONSIDERING the Court's Order dated June ~~15~~¹⁶, 2001 (the "**Wind Up Order**") by which the Commissioner's Wind Up Plan was approved, and by which General Health was ordered to submit a proposal for its contributions to the Wind Up Plan; and

CONSIDERING that it appears from General Health's Petition filed that it has developed a comprehensive proposal (the "**General Health Proposal**") whereby General Health will make significant contributions to the wind up of the affairs of Gulf South so that Gulf South will be able to pay in full, over time, all valid claims owed to its enrollees, providers, and other creditors; that the General Health Proposal was transmitted to the Commissioner by General Health's letter dated June 15, 2001; that the General Health Proposal is consistent with and limited by the obligations of General Health as appears from the letter from General Health's Chief Executive Officer to the Commissioner dated September 17, 1997; that the General Health Proposal gives due consideration to the importance of assuring the continued viability of General Health and its

community mission healthcare system that is essential to Baton Rouge and the surrounding communities; and that General Health's Proposal is in the best interest of the enrollees, providers, and other creditors of Gulf South; and


NOW, THEREFORE, IT IS HEREBY ORDERED that the General Health Proposal is hereby given preliminary approval as part of the Commissioner's Wind Up Plan for the affairs of Gulf South.

IT IS FURTHER ORDERED that a hearing will be held before the Court on **November 5, 2001 at 9:30 a.m.**, in order to allow interested parties to object to or oppose the General Health Proposal; and that any opposition or objection to the General Health Proposal shall be in writing and shall be filed with the Clerk of Court **not later than 5:00 p.m. on October 1, 2001**, with copies being delivered to the Chambers of the undersigned Judge and served on counsel for the Commissioner and General Health, and on Gulf South.

IT IS FURTHER ORDERED that Gulf South shall provide adequate notice of the hearing on the General Health Proposal to all providers and creditors of Gulf South.

IT IS FURTHER ORDERED that this Court shall retain exclusive jurisdiction of all matters related to the General Health Proposal and the Commissioner's Wind Up Plan.





